

## INTERNATIONAL UNDERGRADUATE ADMISSIONS RE-ENROLLMENT FORM

Students who interrupt their studies for one full academic year or longer, must complete a re-enrollment form and submit it along with any and all documentation as is required by the Office of International Undergraduate Admissions.

**Additional documentation may include:**

- Current financial documentation (not older than 6 months)
- Immigration Verification Transfer Form (If currently enrolled at a U.S. college/university)
- Photocopies of current immigration status/classification (If currently in the US)

Upon re-enrollment, students must meet the academic program and degree-completion requirements that are in place at the time of re-enrollment. Re-entering students must meet with an Academic Advisor prior to registration to have their transcripts and requirements assessed. Re-entering students are also advised to meet with a Student Financial Services representative to discuss financial/ payment options.
